



RELEASE OF LIABILITY FORM & WAIVER for

FEEL LIKE A PRO DIRT – Training & Bike Rentals

By signing, I, (please print) _____, acknowledge that all activities sponsored or conducted by Feel Like A Pro Dirt are likely to be extremely hazardous and may result in accident, loss, damage, or injury, ranging from broken bones to paralysis, or even death. Such events may result from any maneuver, whether difficult or not, or could result from defective equipment. I understand that I will also be within close proximities of hazardous and potentially dangerous items including, but not limited to: fences, hay bales, trees, bushes, buildings, sheds, dirt bikes, as well as, other dirt bike riders. With the full knowledge of these dangers, and intending to be legally bound, I hereby agree for myself and on behalf of all of my family and heirs to hereby **release** Feel Like A Pro Dirt and any of its representatives, agents, directors, officers, members, fellow riders and owners of any equipment or property upon which the equipment is located, including but not limited to, the owner of the property on which the Feel Like A Pro Dirt program is located (4980 Konocti Rd. #B, Kelseyville, CA 95451) from any and all liability claims, demands, or any causes of action, and to **not sue or otherwise make any claims against** Feel Like A Pro Dirt or any of its representatives, agents, directors, officers, members, fellow riders and owners whatsoever, which may arise during my participation in any activities of the dirt bike race, training or touring.

I intend this RELEASE OF LIABILITY FORM & WAIVER to be effective whether or not any loss, damage, injury or death **results from the negligence** of Feel Like A Pro Dirt. I understand that negligence means, a failure to do an act which a reasonably careful person would normally do, or the doing of an act which a reasonable person would not do, under the same or similar circumstances to protect him or herself, or others from accident, injury or death. I understand that there are no professional or certified trainers, spotters, or catchers and that a reasonably careful person would probably not even think of participating in the activities of a dirt bike race, training or touring day.

I will follow the advice of and use the services of the provided amateur coaches, spotters, catchers and fellow dirt bike riders at my own risk. I agree to be solely responsible for my own safety and to take every precaution to provide for my own safety and well-being while participating in activities sponsored or conducted by the dirt bike race, training or touring, including, my personal inspection of all equipment and making my own assessment as to whether it is safe and free of defects.

This RELEASE OF LIABILITY FORM & WAIVER is given in the interest of permitting the track, training and touring to exist and serve the dirt bike community and to enable my fellow dirt bikers and myself to feel free to donate our services and to help each other without fear of liability. I further understand that there is no insurance coverage for the track, training or touring and that Feel Like A Pro Dirt provides no insurance coverage for any of the equipment or property. I have represented to Feel Like A Pro Dirt that I have my own medical insurance in full force and effect. I understand that any claim for coverage of medical bills will be submitted to my own insurance company.

My release is given in exchange for the ability to use the dirt bikes and equipment, located on any given track or premise, at any given time and similar waivers to be granted on my behalf by the other members of Feel Like A Pro Dirt and its members. This RELEASE OF LIABILITY FORM & WAIVER has no expiration date.
